Early Records of Mount Desert

Foreword

Abraham Somes and James Richardson came to Mount Desert Island in 1761 for the purpose of establishing a permanent settlement. Over the next several decades they were joined by other families including the Mayos, Higgins, Lelands, Stanleys, Spurlings, Bunkers, Richardsons, Hadlocks, Prays, Youngs and Hadleys to name just a few.

It is important to note that during this time Mount Desert, then known as Mount Desert Plantation, included all of Mount Desert Island and several of the outer islands. In 1796 Eden was set apart from Mt. Desert, Cranberry Isles in 1830, Tremont in 1848 and Southwest Harbor in 1905.

Around 1775 the town fathers began recording town meetings, some of the marriage intentions and cattle marks. The Mount Desert Island Historical Society has a copy of the original Town of Mount Desert Record book that has been partially transcribed by History Journal Editor, Patti Leland-Hanson. Every effort has been made to have an accurate transcription of the original book. The original spelling, grammar and punctuation has been left intact.

The History Journal will be including a series of the transcription in the next few volumes. The first in the series includes all of the town meeting minutes up to 1778.

The language is that of the early settlers. It can, at times, be difficult to follow, nevertheless the decision was made not to edit out some of the minutes but instead to include all of them from the first town meeting to several years prior to the process the townspeople went through to incorporate Mount Desert as a town.

Throughout the transcription of the town meeting minutes there are blank spaces indicating that the writing in the original document was not legible. It was decided to leave the space blank instead of trying to determine what words were once written there. The numbers 20 - 23 represent the pages numbers from the original book.

From a historical prospective the information contained in the meeting minutes helps paint a picture of the lives of the early settlers. From a genealogical prospective the minutes can be an invaluable source in confirming the location where ancestors lived and town activities they were involved in.

It is interesting to note that although more than 225 years have passed since the first town meeting was recorded, some of the same procedures are still in place today.

In the House of Representatives February y: 15 1776 Resolved that the Plantations within this Colony not Incorporated and they are
